WHEREAS, all students enrolled in the Lancaster School District have the right to attend campuses that are safe and secure; and

WHEREAS, safe schools are orderly and purposeful places in which students and staff are free to learn and teach without the threat of physical or psychological harm; and

WHEREAS, an essential element in achieving safer schools is the development of a collaborative and coordinated planning approach at the local level – an approach that is integrated into ongoing school planning efforts and includes participation of students, parents, teachers, administrators, and other school support personnel, as well as representatives of law enforcement, business and community agencies; and

WHEREAS, there is a strong positive correlation between safe schools and high academic achievement and that the Board and Superintendent provide leadership in establishing safe schools, creating enabling policies, developing behavior standards, and providing support and assistance to students to become self-directed and responsible; and

WHEREAS, schools and their partners in planning for safe schools must consider a multitude of critical issues, including the experiences of students, parents, teachers, administrators, and other support personnel; physical settings and conditions; leadership and organization processes; and the general atmosphere and spirit of each school; and

WHEREAS, the substantial benefit of students derive from regular attendance in a safe and orderly school environment justifies a high priority and commitment of attention, policy focus, personnel and fiscal resources.

NOW, THEREFORE BE IT RESOLVED, that the Board of Trustees of the Lancaster School District hereby declares October 2020, as **School Safety Month** and encourages staff to participate in activities to prevent campus crime and violence, develop conflict resolution skills, improve discipline, increase attendance and enhance student achievement, reduce drug and alcohol use, suppress gang activities, and eliminate weapons on campus.

Proclamation Character Counts Month

WHEREAS, the American heritage and laws reflect a common core of personal and social values that hold the citizens of this democracy responsible for acting morally and ethically, being actively involved in school and community, resolving differences peacefully, and respecting the rights, dignity and property of others; and

WHEREAS, the character of a nation is only as strong as the character of its individual citizens, and the public good is advanced when young people are taught that good character counts in personal relationships, in school, and in the workplace; and

WHEREAS, concerns about the character training of children have taken on a new sense of urgency as deteriorating social conditions threaten the physical and psychological well-being of our youth and our nation; and

WHEREAS, although character development is, first and foremost, an obligation of families, the efforts of faith communities, schools, and youth, civic, and human service organizations also play a very important role in supporting families to foster and promote good character; and

WHEREAS, educators are called upon to impress upon students the principles of morality, truth, justice, patriotism, and a true comprehension of the rights, duties, and dignity of American citizenship and the meaning of equality and human dignity, all of which result in awakening students to the moral and ethical virtues that build a fundamental strength of character; and

WHEREAS, the Antelope Valley Career Preparation Council, comprised of local educators and representatives of business, industry and government, have agreed on the work ethics characteristics that are necessary for successful employment and productive citizenship; and

WHEREAS, six common essential ethical values form the foundation of both a successful career and our democratic society: *trustworthiness*, *respect*, *responsibility*, *fairness*, *caring*, *and citizenship*, and these six character traits transcend cultural, religious, and socioeconomic differences.

NOW, THEREFORE BE IT RESOLVED, that the Board of Trustees of the Lancaster School District hereby endorses these six essential ethical values and urges all adults to incorporate these core values into their work with young people in educational programs, in the classroom, on the playground, campus, and athletic field and encourages <u>all</u> citizens to model these traits of good character in an ongoing commitment to promote character development and ethical behavior among the youth of our State; and

BE IT FURTHER RESOLVED that the Board of Trustees declares October as **Character Counts Month** and calls on educators to integrate appropriate activities to embrace these core values into the program of instruction throughout the year.
