### 2024-25 School Description and Mission Statement

LAVA is an Independent Study based school made up of K-8 Virtual Academy and K-8 Home Hospital Program. Our mission is to provide educational pathways for all students, all of the time. Our vision is to build self-driven, goal-directed learners and help students learn how to advocate for their learning needs.

The Lancaster Alternative Virtual Academy (LAVA) and Home Hospital staff work closely with students and their families to find options and excellence in education. Our team of educators work together to serve those who will benefit from an alternative school setting.

## 2024-25 School Description and Mission Statement

The K-8 Virtual Education Program gives families the support and curriculum they need to deliver instruction in the method that best meets the needs of their child. The teacher reviews the content of virtual learning platforms and curriculum with the parents/guardians to help them understand the concept and best way to deliver the information. The areas of study are English, Math, Social Sciences, Science, Physical Education and VAPA. The teacher provides learning clarity by developing Learning Intentions, addresses state standards, grades the work and assesses students using "Success Criteria & I Can" statements to ensure the state standards are being met.

LAVA is a K-8 blended learning, blended teaching program. We strive to meet the unique educational needs of each student to attain their full potential through an innovative, project-based, technology-rich environment. Student progress is monitored weekly by staff from attendance to academics. LAVA offers students a flexible learning environment supported by credentialed teachers who provide virtual face-to-face small group instruction, intervention, feedback and support through digital platforms. The majority of the work is done independently (asynchronously) using an online teaching/learning platform. The teachers provide instruction synchronously or through live interaction. A music teacher provides sessions on minimum day Tuesdays related to music literacy. These workshops are an opportunity for students to socialize, work collaboratively, and experience hands-on learning.

Our K-8 Home and Hospital Program provides instruction to students with a temporary disability directly to the students at home or in a hospital with LAVA's digital platforms. The primary outcome of Home / Hospital Instruction is to maintain the student's former level of performance while recovering from the temporary disability so as not to jeopardize the student's future performance upon returning to school.

## School Facility Conditions and Planned Improvements

### General

The district takes great efforts to ensure that all schools are clean, safe, and functional. ### Maintenance and Repair

District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

### Cleaning Process and Schedule

The district governing board has adopted cleaning standards for all schools in the district. A summary of these standards is available at the district office. The principal works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

### Deferred Maintenance Budget

Although the State no longer requires a Deferred Maintenance contribution, Lancaster School District is still dedicated to maintaining the facilities for our students. These expenditures would include but not be limited to roofing, plumbing, heating, air conditioning, electrical, painting, and flooring. For the 2023-24 school year, the district has budgeted \$2,683,000. for deferred maintenance projects.

## Professional Development

The Lancaster School District provides professional development throughout the school year that trains and supports staff in the effective implementation of our adopted core and cornerstone programs including, but not limited to: Teacher Clarity, PLC+, Standards-Based Grading and Reporting, Structured Literacy, Data Analysis, Leadership Training, Writing Instruction, Coaching, Direct Instruction, Conceptual Development, Building Academic Vocabulary, Culturally Responsive Teaching and Learning (including Capturing Kids Hearts), Integrating Technology into the Classroom, PBIS, Intervention, and Differentiation in Strategies for teaching EL, GATE, and at-risk students. High-quality, ongoing professional development opportunities are recognized as an important component in our work towards continuous improvement in student learning.

Ongoing opportunities include in-services during and after the work day as well as through site and district in-class and on-site coaching. All teachers are provided multiple opportunities to receive optional paid professional development. The school year calendar allows for 37 minimum days in which 26 days are utilized to provide 1-2 hours of district and site designed professional development specific to their needs. Outside workshops, conferences and other in-services that provide more in-depth training and further prepare our staff members to become trainers for our district are available as approved by the Board of Trustees.

Professional development supporting our instructional programs and services for students is also provided for our classified staff members. Additionally, workshops designed to improve technology skills, provide training with key software programs utilized in the district, and offer information on personal excellence and social responsibility are included in the professional development course offerings for classified staff throughout the school year.
