School Description

New Vista Middle School staff provide a warm, nurturing, and academic learning environment for all students in grades 6, 7 and 8. As students advance through their three middle school years here, they transition from two partner teachers in the sixth grade into a departmentalized setting in grades 7 and 8. The staff is committed to the success of each child through the variety of structured programs, enrichments, and interventions. In addition to meeting our students' academic needs, NVMS has created a culture of connectedness among students and staff through Capturing Kids' Hearts, ASB Leadership, PLUS Student Leadership, AVID, Band, Coffees with the Counselors, Pastries with the Principal, Lunch Time Activities, Family Fun Nights, PTO, Cultural Heritage events, and many other positive activities on campus. Students enjoy coming to school as evidenced by our attendance rates.

Our school-wide theme is focused on our college and career bound Tigers! This theme is supported through our growing AVID program that is implemented in our AVID elective and integrated in all courses in all grade levels. (AVID, Advancement Via Individual Determination, is sponsored by both district and site funding.) In addition to our AVID electives, we also provide a variety of electives in order to provide students with options as they pursue their personal best each day. AVID gives support in the areas of writing, inquiry, collaboration, organization, reading, note-taking, study skills, college and career research, and preparation for standardized tests. AVID students also receive additional support from college tutors during their AVID elective class 3 times a week.

These additional electives include, AVID EXCEL (supports EL learners with language acquisition), STEM classes (focusing on Science, Technology, Engineering, and Mathematics), Band, PLUS (Peer Leaders Uniting Students), Band, Choir, Guitar, Art, Spanish I, Spanish II, Yearbook, Computer Literacy, Guided Study Hall, and Teacher Aide. Many of our students take advantage of extra and co-curricular activities on campus including sports, Campus Counselor Time, Robotics, GATE classes and enrichment activities, and CJSF (California Junior Scholastic Federation).

We are committed to the continual refinement of our electives in order to further enhance the academic and extracurricular programs at NVMS so that all students are proud to call themselves Tigers as we support their unique abilities to attend college and pursue the career of their dreams.

General
 The district takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the district uses a facility survey instrument developed by the Los Angeles County Office of Education. The results of this survey are available at the school office or at the district office.

School Buildings
 New Vista Middle was established in 1989 on a temporary site and moved to their current site in 1994. The main building houses the front, health, and principal’s offices, staff lounge, cafeteria, and multipurpose room. There are 52 classrooms—28 that are permanent and 24 that are re-locatable. We have 4 science labs, 2 computer labs and a gym.

Maintenance and Repair
 District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

Cleaning Process and Schedule
 The district governing board has adopted cleaning standards for all schools in the district. A summary of these standards is available at the district office. The Supervisor of Operations works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Deferred Maintenance Budget
 Although the State no longer requires a Deferred Maintenance contribution, Lancaster School District is still dedicated to maintaining the facilities for our students. These expenditures would include but not be limited to roofing, plumbing, heating, air conditioning, electrical, painting, and flooring. For the 2019-20 school year, the district has budgeted \$940,000 for deferred maintenance projects.

The Lancaster School District provides professional development throughout the school year that trains and supports staff in the effective implementation of our adopted core and cornerstone programs including, but not limited to: 21st Century Instructional Strategies, Unit and Lesson Design and Delivery, Data Analysis, Leadership Training, Writing Instruction, Coaching, Direct Instruction, Conceptual Development, Building Academic Vocabulary, Culturally Responsive Teaching and Learning (including Capturing Kids Hearts), Integrating Technology into the Classroom, PBIS, Intervention, and Differentiation in Strategies for teaching EL, GATE, and at-risk students. High-quality, ongoing professional development opportunities are recognized as an important component in our work towards continuous improvement in student learning.

Ongoing opportunities include in-services during and after the work day as well as through site and district in-class and on-site coaching. All teachers are provided multiple opportunities to receive optional paid professional development. The school year calendar allows for 38 minimum days in which 17 days are utilized to provide 1-2 hours of district and site designed professional development specific to their needs. Outside workshops, conferences and other in-services that provide more in-depth training and further prepare our staff members to become trainers for our district are available as approved by the Board of Trustees.

Professional development supporting our instructional programs and services for students is also provided for our classified staff members. Additionally, workshops designed to improve technology skills, provide training with key software programs utilized in the district, and offer information on personal excellence and social responsibility are included in the professional development course offerings for classified staff throughout the school year.
