School Description

Discovery Elementary School is a TK-5 comprehensive school that also houses three SDC classes. The goal of Discovery Elementary is to educate the whole child by providing access to rigorous core and supplemental content material. Students are given multiple opportunities to learn at the level and time they need while using the 4 Cs: Critical Thinking, Communication, Collaboration, and Creativity. Our TK-5 school has a special focus on the areas of science, technology, engineering, arts, and math (STEAM), which will offer students a range of unique, exciting experiences and opportunities.

Discovery's Mission says: "We will prepare all of our students for college and life by providing a challenging and engaging curriculum. Through hands-on authentic exercises such as STEAM (RIGOR), we will promote Critical Thinking, Communication, Collaboration, and Creativity that will bring together our students' lives and their futures (RELEVANCE) in a nurturing and supportive environment (RELATIONSHIPS)."

Discovery School is a place where students learn what it takes to become the innovators of tomorrow. Discovery is a school where students are STARS! Because STARS Stay Safe, Take Responsibility, Aim High, Respect Everyone, Shine Bright all day every day.

Discovery uses the Positive Behavior Intervention and Support (PBIS) program. Expected behaviors are modeled and taught to students and positive behaviors are routinely reinforced. A recreation leader leads positive and engaging activities during recesses and lunch, and a full time school counselor, a full time campus supervisor as well as a full team of duty aides who promote school safety and supervise throughout the day.

About the SARC

General
 The district takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the district uses a facility survey instrument developed by the State of California Office of Public School Construction. The results of this survey are available at the school office or at the district office.

School Buildings
 Discovery School was built in 2011. The main building houses the front, health, and administrative offices, multi-purpose room/cafeteria, staff lounge, computer lab and library. There are 32 classrooms - 8 permanent and 23 relocatable.

Maintenance and Repair
 District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

Cleaning Process and Schedule
 The district governing board has adopted cleaning standards for all schools in the district. A summary of these standards is available at the district office. The principal works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Deferred Maintenance Budget
 Although the State no longer requires a Deferred Maintenance contribution, Lancaster School District is still dedicated to maintaining the facilities for our students. These expenditures would include but not be limited to roofing, plumbing, heating, air conditioning, electrical, painting, and flooring. For the 2019-20 school year, the district has budgeted \$940,000 for deferred maintenance projects.

The Lancaster School District provides professional development throughout the school year that trains and supports staff in the effective implementation of our adopted core and cornerstone programs including, but not limited to: 21st Century Instructional Strategies, Unit and Lesson Design and Delivery, Data Analysis, Leadership Training, Writing Instruction, Coaching, Direct Instruction, Conceptual Development, Building Academic Vocabulary, Culturally Responsive Teaching and Learning (including Capturing Kids Hearts), Integrating Technology into the Classroom, PBIS, Intervention, and Differentiation in Strategies for teaching EL, GATE, and at-risk students. High-quality, ongoing professional development opportunities are recognized as an important component in our work towards continuous improvement in student learning.

Ongoing opportunities include in-services during and after the work day as well as through site and district in-class and on-site coaching. All teachers are provided multiple opportunities to receive optional paid professional development. The school year calendar allows for 38 minimum days in which 17 days are utilized to provide 1-2 hours of district and site designed professional development specific to their needs. Outside workshops, conferences and other in-services that provide more in-depth training and further prepare our staff members to become trainers for our district are available as approved by the Board of Trustees.

Professional development supporting our instructional programs and services for students is also provided for our classified staff members. Additionally, workshops designed to improve technology skills, provide training with key software programs utilized in the district, and offer information on personal excellence and social responsibility are included in the professional development course offerings for classified staff throughout the school year.
